

## POSTGRADUATE STUDENTS Programme Fees for students admitted in Academic Year 2021

The table below shows the tuition fees payable by the postgraduate intake of AY2021. Fees are subject to yearly review and revision and are payable as long as a student's candidature remains active.

For Singapore Citizens and Singapore Permanent Residents, the fees are exclusive of GST as the applicable GST is subsidised by the Ministry of Education. The subsidised fees for international students and non-subsidised tuition fees are inclusive of the prevailing GST rate.

For Programmes by Coursework, the fees payable for each trimester are derived based on the summation of credit units for the modules registered for the trimester, multiplied by the fees per credit unit.
