

## **TERMS AND CONDITIONS**

### **1. DEFINITIONS**

- 1.1 “University” refers to the organiser of the Summer Impact Experience, namely the Singapore Institute of Technology (“SIT”).
- 1.2 “Participant” refers to an individual who has received a Letter of Offer from the University for the Summer Impact Experience.
- 1.3 “Terms and Conditions” refers to these terms and conditions as set out herein, which may be amended from time to time by the University.
- 1.4 “Summer Impact Experience” refers to the SIT Summer Impact Experience from 11 August 2026 to 14 August 2026

### **2. ACCEPTANCE OF TERMS**

- 2.1 By accepting the University’s Letter of Offer for the Summer Impact Experience, the Participant acknowledges that he/she has read and agreed to be bound by these Terms and Conditions.
- 2.2 The University reserves the right to, at any time in its absolute discretion, amend, including without limitation, delete, modify, vary and/or supplement any of these Terms and Conditions without prior notice to the Participants. An amendment made in accordance with this clause shall not require consideration to be legally binding. The University will inform the Participants of such amendments *after* such amendments become effective and the Participants agree that continued participation in the Summer Bootcamp shall constitute their acceptance of the Terms and Conditions (as amended from time to time).
- 2.3 The University also reserves the right to amend the schedule, itinerary and arrangements for the Summer Impact Experience at any time. In such event, the University shall exercise reasonable efforts to ensure that the alternatives provided are of comparable standard, and no compensation shall be payable to the Participant as a result of such changes.

### **3. ELIGIBILITY AND GUARDIAN REQUIREMENT**

- 3.1 The Summer Impact Experience is open to regional high school and pre-university students who are between 16 and 19 years old.
- 3.2 Where the Participant is under 18 years of age at the point of registering for the Summer Impact Experience, the Participant shall ensure that his/her parent/legal guardian review, acknowledge, and consent to the Letter of Offer and these Terms and Conditions on the Participant's behalf. In such case, the University reserves the right to request for the Participant to submit further documentation evidencing his/her parent/legal guardian’s approval for his/her participation in the Summer Impact Experience and may request for such parent/legal guardian to execute an indemnity form in favour of the University.

#### **4. PARTICIPATION FEES**

- 4.1 The Participant shall pay SGD\$1,200 (inclusive of applicable Goods and Services Tax) to participate in the Summer Impact Experience (the “Fee”).
- 4.2 Where a Participant chooses to not participate in an activity/meal that the University has scheduled for the Summer Impact Experience, the Participant understands that they will not be entitled to a refund of the Fees for the “unconsumed” activity/meal.
- 4.3 For the avoidance of doubt, the Fee does not include accommodation, airfare, airport transfers, travel insurance, meal and travel expenses. Any other expenses not stated in this clause shall be at the sole expense of the Participant unless otherwise agreed by the University in writing.
- 4.4 The Participant is solely responsible for the booking, purchase and payment of their own international and domestic air travel to and from Singapore for the purposes of the Summer Impact Experience. For the avoidance of doubt, the University shall bear no responsibility or liability for any flight arrangements, changes, delays, cancellations, missed connections, or related costs and the Participant shall not seek to hold the University responsible for the same.
- 4.5 The Participant understands that full payment of the Fee as per the payment terms set out above is mandatory to secure his/her registration for the Summer Impact Experience. The Participant shall not hold the University liable for any losses/damages arising from the Participant’s failure to meet the payment obligations set out in these Terms and Conditions.

#### **5. INSURANCE AND MEDICAL COVERAGE**

- 5.1 The Participant shall, at his/her own expense, purchase and maintain valid personal travel and medical insurance to cover the entire duration of their stay in Singapore and the Summer Impact Experience. Responsibility for adequate insurance coverage rests solely with the Participant.
- 5.2 The University reserves the right to request the Participant to produce documentary proof of such insurance coverage prior to the commencement of the Summer Impact Experience.

#### **6. WITHDRAWAL AND REFUND POLICY**

- 6.1 The Participant may choose to withdraw from the Summer Impact Experience after acceptance of the Letter of Offer with written notice to the University after registration has been confirmed. However, the Participant agrees to be subject to the following conditions for withdrawal:
- (a) Where a Participant gives the University notice of withdrawal *before* the closing date for registration, the University shall refund the Participant 100% of the Fees paid.
  - (b) Where a Participant gives the University notice *after* accepting the University’s offer for the Summer Impact Experience but 7 days *before* the commencement of the Summer Impact Experience, the University shall refund the Participant 50% of the Fees paid.
  - (c) Where a Participant gives the University notice *after* the commencement of the Summer Impact Experience has commenced, the Participant shall not be entitled to any refund of the Fees paid.
- 7.2 Where travel advisories or restrictions are issued by any government authorities which prevent the Summer Impact Experience from taking place, the Participant agrees to abide by the refund mechanisms stated above.

7.3 For the avoidance of doubt, the Participant understands that the processing of a refund will incur reasonable administrative fees of at least SGD\$20 and other bank charges, and shall allow the University to set off such reasonable charges against the Fee to be refunded to the Participant. The Participant also acknowledges that the processing of the refund may take between 4 and 8 weeks to be completed, subject to the Participant's timely submission of all documents required by the University to process the refund.

## **8. CONDUCT**

8.1 The Participant shall comply with all rules, regulations, guidelines, policies and directives prescribed by the University (as may be amended and/or supplemented from time to time).

8.2 The Participant must comply with all immigration, security and entry requirements for his/her attendance of the Summer Impact Experience. The University will not be responsible for any delays, refusal of entry or deportation for any reason. The Participant shall also comply with all applicable laws of Singapore for the duration of the Summer Impact Experience.

8.3 The Participant also agrees to comply with and fully participate in the University's procedures and mechanisms (as set out in such policies) in any event of misconduct by the Participant. The University reserves the right to impose disciplinary actions and sanctions on a Participant for any misconduct, including immediate dismissal from the Summer Impact Experience without refund.

## **9. INDEMNITY AND LIMITATION OF LIABILITY**

9.1 To the extent permissible by law, the Participant (including his/her heirs, parents, legal guardians, executor and/or administrator) accept and shall not hold the University liable for all risks of injury, illness, expenses loss or damage to personal property, and damage of any nature whatsoever related to the Participant's involvement in the Summer BImpact Experience.

9.2 To the extent permissible by law, the Participant (including his/her heirs, parents, legal guardians, executor and/or administrators) shall hold harmless and indemnify the University against any and all liabilities, losses, damages, claims, injury, actions, proceedings, expense and cost which may result in relation to their participation in this Summer Impact Experience and/or breach of these Terms and Conditions, except for liability which cannot be excluded by law.

9.3 To the fullest extent permitted by law, the University shall not be liable for indirect, consequential, special, exemplary, punitive or indirect damages, losses, cost or expenses, including but not limited to economic loss, loss of goodwill, loss of reputation, loss of business, loss of revenue or profits.

9.4 The University's maximum aggregate liability to each Participant shall not exceed the Fees paid by the Participant.

## **10. FORCE MAJEURE**

10.1 Save as is otherwise specifically set out in these Terms and Conditions, the University shall not be liable for any failure or delay in performance of its obligations hereunder arising from events beyond its reasonable control, including but not limited to Acts of God, natural disasters, war, terrorism, civil unrest, government orders or regulatory restrictions, public health emergencies, failure of utilities or infrastructure, fire, flood, epidemics, and pandemics ("Force Majeure Event").

10.2 If a Force Majeure Event occurs, the University may suspend, modify, postpone, convert to online delivery, or cancel the Summer Impact Experience, and/or adjust academic requirements or assessment modes. The University retains the discretion to offer the Participant a refund for the Summer Impact Experience in the case

of a Force Majeure Event and may set off its reasonable preparatory expenses against the refund to be processed to the Participant.

## 11. PRIVACY AND PERSONAL DATA CONSENT

- 11.1 The University will comply with the applicable data protection laws, including the Personal Data Protection Act (“PDPA”).
- 11.2 By accepting the Letter of Offer, the Participant agrees that the University may collect, use, disclose and/or process the Participant’s Personal Data for one or more of the following purposes:
- 11.2.1 administering, facilitating, performing, dealing with and/or managing the contractual relationship between the Participant and the University hereunder, including for purposes related to processing the application, academic administration, immigration and regulatory compliance, and any other purposes necessary or reasonably required for the purposes of these Terms and Conditions or the Summer Impact Experience;
  - 11.2.2 responding to any proposal or enquiry from (or purported to be given by) the Participant in relation to these Terms and Conditions or the Summer Impact Experience;
  - 11.2.3 carrying out due diligence or other screening activities (including background checks) in accordance with legal or regulatory obligations or the University’s risk management procedures that may be required by law or that may have been put in place by the University;
  - 11.2.4 to prevent or investigate any fraud, unlawful activity or omission or misconduct;
  - 11.2.5 complying with or as required by any applicable law, or governmental or regulatory requirements of any relevant jurisdiction;
  - 11.2.6 complying with or as required by any request or direction of any governmental authority; or responding to requests for information from public agencies, ministries, statutory boards or other similar authorities; and
  - 11.2.7 storing, hosting, backing up (whether for disaster recovery or otherwise) of the University’s data, whether within or outside Singapore.
- (individually, a “**Purpose**”, collectively the “**Purposes**”).
- 11.3 The University may need to disclose the Participant’s personal data to third parties, whether located within or outside of Singapore, for one or more of the above Purposes set out at Clause 11.2, as such parties would be processing the Participant’s personal data for one or more of the above Purposes. In this regard, the Participant hereby acknowledges and agrees and consents that the University is permitted to disclose the Participant’s personal data to such third parties (whether located within or outside Singapore) for one or more of the above Purposes and for the said third parties to subsequently collect, use, disclose and/or process the Participant’s personal data for one or more of the above Purposes. Without limiting the generality of the foregoing or of this clause, such third parties include:
- (a) the University’s associated or affiliated organisations and overseas university partners;
  - (b) any of the University’s agents, contractors or third party service providers that process or will be processing the Participant’s Personal Data on the University’s behalf including but not limited to those

which provide administrative or other services to the University such as mailing houses, telecommunication companies, information technology companies and data centres; and

- (c) third parties to whom disclosure by the University is for one or more of the Purposes and such third parties would in turn be collecting and processing the Participant's Personal Data for one or more of the Purposes.

## **12. PUBLICITY**

- 12.1 Each Participant consents to participate in the publicity activities of the University in relation to the Summer Impact Experience and other future publicity without any payment or compensation thereof.
- 12.2 The University and its Partner institutions/companies (where applicable) may take photographs and/or videos during the events or activities scheduled for the Summer Impact Experience, which could include images or voices of Participants and passersby. The Participant acknowledges and agrees that if he/she is photographed or recorded, the University and/or the other Partner Institutions/Companies (where applicable) may collect, use and/or disclose these photographs and/or videos for their publications (including on websites and social media channels) for publicity and archival purposes. If the Participant does not wish to be photographed or recorded, the Participant should remove himself/herself from the group and candid photographs/recordings which the photographers/videographers intend to capture.

## **13. THIRD PARTY RIGHTS**

- 13.1 Save as expressly set out in these Terms and Conditions, a person who is not a party to this contractual relationship (and the Terms and Conditions set out herein) shall have no rights under the Contracts (Rights of Third Parties) Act 2001 to enforce any term herein.

## **14. GOVERNING LAW**

- 14.1 These Terms and Conditions (and all its subsequent amendments) shall be governed by and construed in accordance with the laws of the Republic of Singapore. If a dispute arises in connection with the Summer Impact Experience, such dispute shall be subject to the exclusive jurisdiction of the Singapore courts.
- 14.2 To the extent that any provision of these Terms and Conditions is held by a court of competent jurisdiction to be wholly or partly illegal, invalid or unenforceable, the same shall be deemed to be severed from these Terms and Conditions and shall be of no force and effect. The remaining provisions shall remain in full force and effect.

## **15. OTHERS**

- 15.1 The Participant acknowledges and understands that the University does not appoint, authorise or act through any third party (including but not limited to overseas agents, organisers, or travel or accommodation providers) in relation to the Summer Impact Experience ("Third Party"). No Third Party has any authority to act for, represent, bind or make any representation, warranty, undertaking or assurance on behalf of the University.
- 15.2 Any services arranged or provided by Third Party(ies) (including accommodation, transport, meals, insurance, visa or travel related services) are entered into strictly between the Participant and/or the Participant's parent(s) or legal guardian(s) (as applicable) and the relevant Third Party, at the Participant and/or the Participant's parent(s)' or legal guardian(s)' sole risk and discretion. SIT is not a party to, does not endorse, and assumes no responsibility or liability whatsoever in respect of such arrangements or services.
- 15.3 The parent(s)/legal guardian(s) shall jointly and severally indemnify and hold harmless SIT from and against any and all claims, demands, losses, liabilities, costs and expenses (including legal costs on a full indemnity basis) suffered or incurred by the University arising out of or in connection with any claim by or on behalf of

the Participant and/or his/her parent(s)/legal guardian(s) relating to any Third Party or any services provided by such Third Party.

15.4 Each parent or legal guardian represents that he or she has the full legal authority to enter into this contractual relationship with the University and to give the waivers, releases and indemnities herein on behalf of the Participant.

## **16. DECLARATION**

16.1 By accepting the University's Letter of Offer, the Participant hereby declares that he/she has read and understood and will comply with the Terms and Conditions stated herein. The Participants further confirms that the information provided is true and complete, and that he/she will update Admissions and Financial Admissions if there are any changes to the personal information provided to the University.
