

UNDERGRADUATE STUDENTS Programme Fees for students admitted in Academic Year 2020

The University adopts a cohort-based fee system. The table below shows the tuition fees per trimester payable by the new undergraduate intake of AY2020 for their candidature. The fees payable for each trimester are derived based on the summation of credit units for the modules registered for the trimester, multiplied by the fees per credit unit. Fees are payable as long as a student's candidature remains active.

For Singapore Citizens and Singapore Permanent Residents, the fees are exclusive of GST as the applicable GST is subsidised by the Ministry of Education. The subsidised fees for international students and non-subsidised tuition fees are inclusive of GST. The prevailing GST is 9% with effect from 1st January 2024.
